



Overview

Ngāti Tūwharetoa Mercury Development Group was established as a result of a partnership agreement between Ngāti Tūwharetoa and Mighty River Power (now Mercury) in October 2002. The Development Group is charged with the task of supporting Ngāti Tūwharetoa in sporting, cultural, educational and environmental projects.

Key Objective

The key objectives of the Ngāti Tūwharetoa Mercury Development Group (NTMDG) are:

- Enhancing the spiritual and cultural relationship of Ngāti Tūwharetoa with Lake Taupō, the Waikato River, and related taonga.
- Conducting environmental enhancement projects, remedial works, and scientific studies in and around Lake Taupō, the Waikato River, and adjacent lands.
- Facilitating the exercise of kaitiakitanga by supporting activities and projects that contribute to this goal.

About the Fund

The Kaitiaki Project Fund was established by Ngāti Tūwharetoa Mercury Development Group to support larger, high-impact environmental projects led by hapū, marae and iwi.

Its purpose is to enable more substantial Kaupapa - projects that deliver stronger, long-term benefits for our people and our Taiao, including Lake Taupō, the Waikato River, and the wider environment. This fund is designed for initiatives that require a heavier investment and create meaningful, measurable outcomes.

Funding is available under three components. Please select one:

- Multi-Year Environmental Project**
- Contestable Taiao Project Fund**
- Special Marae Grant - Kaitiaki**



1. Multi-Year Environmental Projects

Purpose:

To support large-scale, multi-year projects that deliver long-term environmental outcomes for Ngāti Tūwharetoa.

Funding available:

- Up to three new multi-year projects will be funded annually.
- Individual multi-year projects will have a funding cap of \$100,000 each, allocated as follows:
- Changes to this annual funding structure may be considered by the NTMDG, at its discretion.
- If a project is planned for two years instead of three, it may still access up to \$100,000, subject to approval by the Group. However, the total annual funding across all projects must be managed within the Group's available funding.
- If funds are not allocated during the February multi-year project funding round, they will be released into the contestable funding pool.

Multi-year funding of up to \$100,000 is available per project, allocated over three years as follows:

- Year 1: \$40,000
- Year 2: \$40,000
- Year 3: \$20,000

Criteria:

- Requires hapū endorsement and a full business case.
- Must show alignment with NTMDG environmental objectives.
- Must include measurable outcomes and sustainable practices.
- Must include a detailed project plan and budget.
- Requires proof of permissions (hapū, landowners, councils).
- Reviewed annually at the **February** NTMDG meeting
- Meets reporting requirements.

2. Contestable Taiao Project Fund

Purpose:

To support smaller or one-off environmental projects that contribute to NTMDG taiao objectives.

Criteria:

- Open to all applicants who meet NTMDG environmental criteria but do not qualify for multi-year funding.
- Must include a detailed project plan and budget
- Requires proof of permissions (hapū, landowners, councils).
- Preference given to hapū-endorsed projects.
- Applications reviewed in **March** funding rounds

3. Special Marae Grant - Kaitiaki Taiao

Purpose:

To help marae carry out kaitiaki mahi that protects and improves the environment in their own hapū. The marae has full control over how the funding is shared with whānau and how it is used for their kaupapa.

Funding available:

Up to **\$30,000 per marae** as a one off grant if not utilised then it will be held to the following year.

Criteria:

- Open to eligible hapu/marae registered and listed on the TMTB website: <https://www.tuwharetoa.co.nz/our-marae/>
- Project must align with NTMDG environmental objectives.
- Marae requires hapū letter of endorsement & resolution confirming support.
- Proposal must include objectives, milestones, and a budget breakdown.
- Funds must be used for the approved purpose within the agreed timeframe.
